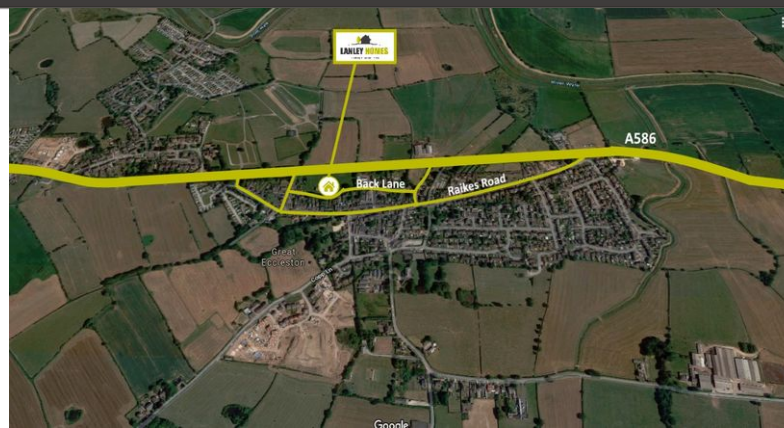
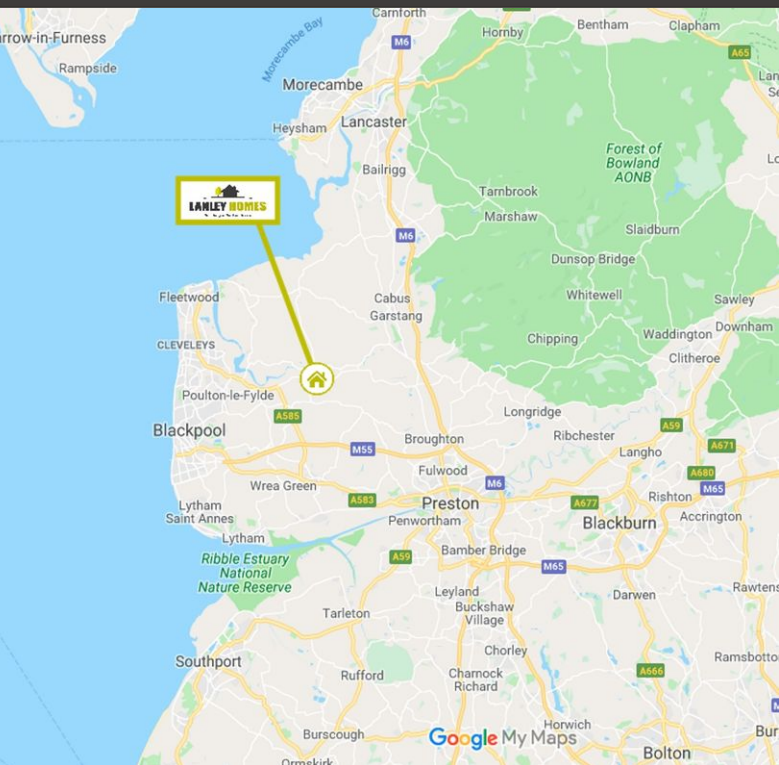

### LOCATION

Great Eccleston is an idyllic village set in Lancashire on the Fylde coast. The village lies to the south of the River Wyre and the A586 road, approximately 10 miles upstream from the port of Fleetwood.

Bowland View is situated on the edge of the village. The new development is accessed off Back Lane and the village centre is within a very short walk. The A586 is easily accessible providing good transport links to the wider region.
